

Privacy Policy, Terms of use and other conditions of Yceberg.com

You are visiting and browsing websites which content and functional principles are own by website owner named below as Owner. By visiting our website you entrust us your personal information and you undertake to comply with the terms of use described below. Here's what we collect and how we use it.

Owner of Yceberg.com is Mgr. Miroslav Janura Litovelská 678/12, 02401 Kysucké Nové Mesto, Slovakia

he is the author of the idea, the principles of functioning, behavior, reward and motivation of user/visitor in website Yceberg.com, as well as the author of the idea of tools to increase the motivation and progress of website users/visitors. He is also the author of the whole website functionality of the Yceberg platform. At the same time, he is the sole owner of the full copyright of Yceberg.com. Furthermore, in these terms only referred to as Owner.

Website

is the Yceberg.com site and all its subdomains on which the Yceberg platform operates and its principles are, in the manner in which the social networks operate, the sole property of the Owner and are subject of trademarks, copyright and copyright laws of the Slovak Republic, EU and international law. Furthermore, in these terms only referred to as Website.

Visitor

Website Visitor is everyone who visits the website Yceberg.com. There are no age or demographic restrictions. Visitors can support the website Yceberg project, they can promote the website idea in their neighborhood, but it is prohibited to copy content, website idea, principles and any other parts of the website. All rights, obligations and privacy rights of visitors are described in these terms below. Furthermore, in these terms only referred to as Visitor / Visitors.

Tranformation from status Visitor to status User

can happen in two cases. In the first case, if Visitors are interested in creating their own Profile and Programs on the Website and in this sense they contact Owner. This contact changes the rights and obligations of visitors - see the Terms below, part A 3).

The other way of this transformation is to change project status from the status of Website to the status of Social network / Platform of Yceberg. In this case, Owner will update or change the Terms and will inform by sending this updated Terms to all registered Visitors. New terms will also be posted on the Website / Social Network /Platform of Yceberg.com. Owner is not responsible for delivering new terms to the email address and also for restrictions and failures of email and internet servicies of Visitors / site user sides and services that may affect delivery of new rules and terms to visitors.



A) Privacy Policy

List of processed personal data and other data:

- 1.) Cookies.
- 2.) Personal information you provide to us by submitting a form.
- 3.) Data (personal data, texts, photos, videos etc.) provided by mail.

A 1.) Cookies

Cookies are small data files that are issued to your device memory, to web browser memory, when you visit a website and that store information about your use of a service.

These files are anonymous and contain information such as language, type and version of your browser, and other settings when viewing the page (but not information about person using it). Your browser sends us cookies that serve to analyze Visitors / User's behavior on our Website and to improve and simplify their usability and ensure the proper functioning of the site.

We use Google Analytics for analysis. Cookie expiration time is 12 months.

A 1.1) Setting cookies in browser.

Cookie settings can be changed in your web browser settings. By deleting, turning off or block cookies you will be able to visit our Website, but some features may not work properly.

A 2.) Forms, contact forms

Visitors / Users who sends us an email via the form voluntarily agree to the processing of his/her personal data (name, email, phone, IP) according to Art. 6 para. 1 (a) (a) Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data (General Data Protection Regulation - "GDPR") and under the Data Protection Act No. , According to § 13, §14 and §19 of Law No. 18/2018 Collection of Laws on the Protection of Personal Data and pursuant to Section §12 of the Civil Code of the Slovak Republic. Sent data will be used to communicate the message content sent by the sender, in particular to inform visitors about news from Yceberg.com, to announce the launch of the Yceberg crowdfunding campaign, or to send a marketing cooperation offer. The data from form will be archived for three years and then will be deleted. Personal information can also be used to send newsletters, and email offers.

A 2.2) Access to personal data

We do not publish, disclose, allow access to data (described in parts A 1 - A 2) to other entities or third party. Data are protected at multiple levels.

A 2.3) Rights of visitors by EU laws

Visitors can ask by written email only, for these rights:

- access to his/her personal data,
- the right to rectify, delete or limit the processing,
- the right to object to processing,
- the right to portability of data,
- the right to withdraw the consent to the processing of personal data at any time,



- the right to lodge a complaint with the supervisory authority, which is the Office for Personal Data Protection of the Slovak Republic,
- the Right to forget, delete personal data the right to revoke personal data processing at any time.

A 2.4) Other

The Owner undertakes never to sell or make the user's personal information available to any third party other than provided for in these terms and conditions, unless the Owner iscompelled to do so by law.

Whilst the Owner will do all things reasonably necessary to protect the Visitors / User's rights of Privacy, the Owner cannot guarantee or accept any liability whatsoever for unauthorised or unlawful disclosures of the Visitors/ User's personal information, whilst in their possession, made by third parties who are not subject to our control, unless such disclosure is as a result of their gross negligence.

A 3) Data (personal data, texts, photos, videos etc.) provided by mail
